Please note that EDDR requests pose additional barriers to city staff's timely response, including that a majority of the electronic data search results produce massive data files to review, most of which may turn out to be irrelevant but must be manually reviewed regardless. OPD currently has only one staff person trained on the many steps needed to fulfill EDDR requests, which include extracting, reviewing, and redacting email searches. Staff devotes 10% of their time per week to EDDR requests, which comprise less than a quarter of the entire universe of Public Records Requests received by OPD staff on a weekly basis." We will release information as it is completed and on a rolling basis. The status of this request will be updated in 90-days.

You will be notified if it is later determined that additional records/information must be withheld by law. In the event that OPD denies your request, under Oakland Municipal Code § 2.20.270(C), you have the right to mediation within 10 days before the Oakland Public Ethics Commission.
