



Dear Lt. Jennings,

I wanted to follow up on our meeting yesterday with the San Jose PD team. It was wonderful to meet you! San Jose PD is such a great department, and I'm looking forward to working with you moving forward.

I've summarized the key feedback and issues discussed for your reference:

#### Feedback and Issues from the RTCC Team:

- **Watermark:** The watermark is showing up on searching, potentially blocking part of the image.
- **Legacy Search:** The legacy search to sort from newest to oldest (A-Z) by plate is no longer there - it was useful and your team would like it back.
- **Camera Downtime:** The team would like to be notified when cameras go down. (This is most likely coming.)
- **Polygon Bug:** The search results do not change in a polygon search when the selected cameras are changed.
- **Search Results & Filters:** Filters are not consistent in different images, causing a lack of trust in filters.

- Look into beta testing FREEFORM at San Jose PD

- Create or locate training resources for

I would like to schedule future time to meet with representatives of Patrol, Investigations, and Admin (and RTCC again if you have more feedback) to see how we can continue to best support your agency, as well as go up with the Air Support unit.
