# This \$4 Billion Car Surveillance Startup Says It Cuts Crime. But It Likely Broke State Laws.

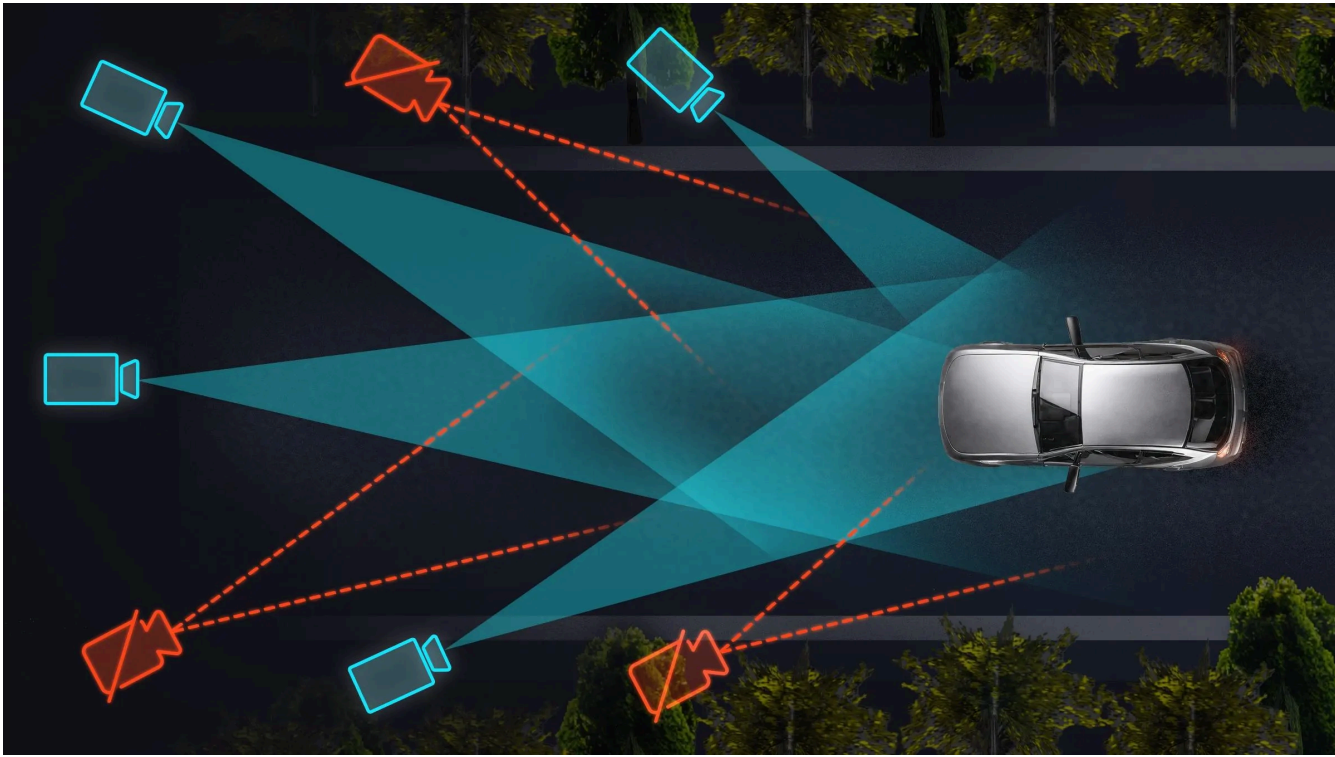

Flock became a law enforcement juggernaut by pledging to eradicate crime with AI-powered license plate readers. But local officials in multiple states told *Forbes* Flock had violated state laws designed to guarantee driver safety in the process.

The AI surveillance cameras on John's Pass Bridge, southwest of Tampa, Florida didn't last a week before they were flagged for breaking state rules. Installed in February 2023 on behalf of car surveillance

startup Flock Safety and its customer, the Treasure Island Police Department, the devices had been placed there without the approval of the Florida Department of Transportation. It wanted them taken down.

In October, the agency was still waiting for their removal. “FDOT is requesting that the Flock camera on the John’s Pass Bridge be removed,” an FDOT official wrote to Flock, according to emails obtained by *Forbes*. “FDOT does not allow installations on our structures except for special cases.” In November, a Flock employee took the camera down, the company confirmed.

For Flock, a \$4 billion company on a mission to “[reduce crime in America by 25%](#)” this might sound like a simple paperwork slip-up, an anomaly. But it’s one of hundreds of such incidents across the country. Company communications with state transportation agencies obtained via public records requests, and interviews with more than half a dozen former employees, suggest that in its rush to install surveillance cameras in the absence of clear regulatory frameworks, Flock repeatedly broke the law in at least five states. In two, state agencies have banned Flock staff from installing new cameras.

These violations are largely the result of the venture-backed startup’s habit of installing its surveillance devices along public roadways



without the necessary permits. Those documents are part of an approval process designed to ensure the cameras are positioned safely, don't compromise utility lines or traffic lights and cannot be dislodged by bad weather or accidents. As one former Flock employee put it, permitting is intended to make certain that "if a car hits a camera going 80 mph, it's not going to go through somebody's window shield."

Responding to a detailed list of questions, Flock spokesperson Josh Thomas told *Forbes* that the company has nearly 50 people dedicated to permitting and "operates to the best of our abilities within the bounds of the law." He said that since jurisdictional boundaries are not always clear, Flock didn't always know when and where it should be applying for a permit. "For the tens of thousands of permits we have applied for, and the tens of thousands of locations that do not require permits, we have certainly not been perfect," Thomas said. "But we try to respond and fix any issues, or we make the effort to retropermit as needed."

Founded in 2017, Flock's surveillance system uses AI to "fingerprint" cars based on make, model and appearance — not just license plate numbers. It claims to currently operate in 4,000 cities in over 42 states where it has found an eager clientele in local police departments who say it costs less than competing devices and is better at detecting suspect cars. A typical Flock camera system starts

at \$3,000 a year, considerably less than rival Motorola's Vigilant's system. Since 2020, [Flock has seen a stunning 2,660% spike in revenue](#), one that landed it on Deloitte's Fast 500 list in 2023 (the company declined to comment on revenue numbers).

That spectacular growth has made investors giddy: Flock raised \$100 million in a July 2023 fundraise led by Andreessen Horowitz, which valued it at over \$4 billion. But the company's growth has been bolstered by unpermitted deployments. Company correspondence reviewed by *Forbes* reveals that Flock has deployed hundreds of unapproved cameras in Florida, Illinois and South Carolina, where it is a crime to install devices on state infrastructure without Department of Transportation approval. And it's run afoul of regulators in Texas and Washington over permitting issues.

In South Carolina, State Transportation Secretary Christy Hall told *Forbes* that since spring 2022, her staff has found more than 200 unpermitted Flock cameras during routine monitoring of public roads. In July 2023, the agency put a

moratorium on new installations and ordered a safety and compliance review of all Flock cameras across the state.

“It is unclear to us as to whether or not these devices are authorized to be on the state-owned right of way,” Hall told *Forbes* earlier this year (she has since announced plans to retire in March). “And there has not been public policy put into place by the South Carolina legislature regarding the use of these devices, [or the] privacy concerns regarding the collection, handling and disposition of the data they collect.”

Flock spokesperson Thomas confirmed the company had paused installation in South Carolina and hopes “to see this permitting process reopen.”

In January 2023, South Carolina Rep. Todd Rutherford introduced a bill into the state legislature that would outline how and when license plate readers can be deployed. Rutherford, who said he was unaware Flock had been deploying cameras without permits across his state, expressed concern about Flock's expansion without any regulatory framework in place to govern it. “People don't know what is happening

with that data, who is accessing it, who is keeping it. All of that infringes on our personal freedom without our knowledge,” Rutherford told *Forbes*. He continued: “It’s getting to the point where a company is willing to break the law to install these cameras.”

In North Carolina in November 2023, a judge enjoined Flock staff from installing new cameras after a division of the state’s Department of Public Safety [sought an injunction against it arguing the company had been operating without the required license](#). Flock disputed the complaint, claiming it did not need any sort of clearance from the North Carolina Alarm Systems Licensing Board because it “[is not in the alarm system business](#)”; the statute applies to any device used to detect illegal activity. Thomas said Flock has since been permitted to have a third party install its devices.

Previously, in 2021, Flock ran afoul of local government in Lake County, Florida after it installed 100 cameras without notifying officials. “It is a violation of procedure and, quite frankly, the law for them to do this,” [said](#) one Lake County commissioner in a board meeting. Flock removed the devices. As of this month, Lake County

Sheriff's Office has not deployed any more Flock cameras, Lieutenant John Herrell confirmed.

Thomas said Flock believed it had installed devices with permission in Lake County, and "as we learned otherwise, we stopped or removed the devices."

But as state officials grumbled, cops raved — and kept buying. Tim Martin, a former police officer in Huntington Beach, California, was an early user of Flock's surveillance cameras and described them as "one of the greatest technological advancements" of his career. It "completely changed how we did investigations," he told *Forbes*.

---

Flock's origin story begins not in law enforcement, but in app stores. Prior to the company's 2017 launch, CEO Garrett Langley was president of Atlanta startup Moment, an app that allowed friends to buy one another "coffee, lunch, or a treat" with the goal of "making people nicer"; his personal website lists additional startup ideas including non-alcoholic wine and unspecified innovations around toilets. CTO Matt Feury was the creator of Saucillator, a digital synthesizer app. The duo met at mobile ticketing and events company Experience. When a spate of robberies hit Langley's Atlanta neighborhood, it inspired them to team up on car surveillance. Flock declined to make its executives available for interviews.

At a recent Andreessen Horowitz event, Langley [said](#) Flock cameras now cover almost 70 percent of the population and are used to solve about 2,200 crimes a day. According to data obtained via a public records request, a network of 309 Flock cameras in Riverside County, California scanned 27.5 million cars in a single month. Riverside’s contract with Flock is worth \$4 million and runs until June 2026.

But while Flock’s law enforcement business had become a runaway success story, it repeatedly ran into issues like those in the Carolinas. “What Garrett doesn't understand is that he is also running a construction company,” one former employee said of Langley and Flock’s recurring missteps with transportation department approvals.

The company’s permitting division was supposed to streamline and expedite camera installations by working with state transportation agencies to ensure that the cameras the company sold to police could legally and safely be put out on public highways. In some states, like Kansas, Kentucky and Oklahoma, emails showed relationships with transportation officials were cordial and efficient. Kansas Department of Transportation staff

attorney Harrison Baker said its permitting team “has a close relationship with Flock’s team and typically problems are solved before they appear.”

But in other parts of the U.S, Flock frequently frustrated DOT officials. Emails reviewed by *Forbes* show that Flock’s permitting team sometimes struggled to comprehend state rules and regulations, filing flawed applications and being denied permits as a result. In Illinois in June 2022, after finding at least 38 cameras had been put up without permits, an IDOT employee chastised Flock for repeatedly submitting “multiple permit requests, all with the same problems/errors” that couldn’t be approved. “If Flock had to remove cameras or get retroactive permits then that’s pretty good evidence that they did not comply with Illinois law and/or IDOT procedures,” said Channing Blair Hesse, partner at Chicago-based law firm Grogan Hesse & Uditsky.

Similarly, in April 2023, a Texas official complained that “Flock sometimes likes to bypass the proper channels,” and TxDOT denied approval for an array of 136 cameras across the state because of unsafe locations; some were to be mounted behind guardrails or on traffic lights.

Last July, Flock was forced to audit all its cameras in Florida for compliance with updated laws for automated license plate readers (ALPR), and either apply for new permits or remove them. An email from a Flock permitting manager to the state’s Department of Transportation showed as many as 842 cameras in need of review.

“Our hope is to not have to remove any cameras and work towards a viable solution to bring everything up to FDOT standards while still keeping them in service for our law enforcement partners,” a Flock permitting employee wrote to FDOT. It’s unclear if Flock has obtained the right permits or if any cameras have been removed.

In June 2022, after being chastised about repeated, error-strewn permit applications in Illinois, a company representative told an IDOT official it was in their best interests to fast track the process.

“I have been trying my hardest to stop all of these law enforcement agents from stopping down to your office because they are all extremely upset,” he said. “About 30 different police chiefs... We have asked them to please not stop into your office.”



The representative claimed it was vital to get permits approved because Flock's cameras had helped them catch the suspect of a mass shooting in Highland Park that had left seven dead. Highland Park Police Department declined comment on that incident, as did Flock.

Flock spokesperson Thomas said that "because of the literal life or death situation that many cities face with violent crime, we're proud of the fact that our installation teams move very quickly. Last year alone, we submitted tens of thousands of permits and stood in front of hundreds of city councils seeking approval."

Flock has tried to address its permitting problems, firing its permitting director in March last year, two former employees told *Forbes*. And it has found a new way to expand that also helps put it on the good side of the transportation officials it previously angered.

In Texas, where Flock had so irked transportation department officials that one threatened "consequences" if the company were to "skip the escalation ladder again," it was able to smooth things over — and sign up a new client. In September last year, the agency agreed to launch a pilot program to use Flock's cameras for traffic analysis, which is set to begin as soon as it gets state procurement approval.
