

FIRST AMENDMENT OF SUBGRANT AGREEMENT

THIS AGREEMENT is entered into as of this 31st day of January 2020, by and between COBB COUNTY through its Board of Commissioners, (hereinafter referred to as the "Subgrantee") and the ATLANTA REGIONAL COMMISSION, (hereinafter referred to as "ARC").

WITNESSETH THAT

WHEREAS, the parties hereto did enter into an agreement dated June 1, 2019, in which the Subgrantee agreed to perform certain services for ARC and ARC agreed to compensate the Subgrantee for the performance of such services, all as more fully set forth in said contract; and

WHEREAS, the parties wish to amend said contract in certain respects as set forth herein below.

NOW, therefore and in consideration of the mutual benefits to the parties, the parties agree that said contract is hereby amended as follows:

1. Section 3, Time of Performance, shall be amended to read, "All services required hereunder shall be completed by or before May 1, 2020."

Except as specifically modified hereinabove, the remainder of said contract shall remain in full force and effect.
