Per our recent telephone conversation, please use the following link <https://www.memphistn.gov/cms/One.aspx?portalId=11150816&pageId=12088729> (desktop computer version) to submit a public records request with the City of Memphis. After clicking the link, you should see a web page titled Communications, scroll downwards on the screen and under the **Request Public Records** section there are two blue boxes, select the **Submit a New FOIA Request** link and click the **Create Account** link (if you are a new user) then fill in the information requested in order to submit your records request with the City of Memphis. If you are having trouble with the link simply visit the City of Memphis website www.memphistn.gov and click on Government, then select Communications and follow the instructions referenced in the second sentence above. Please be sure to attach proof of Tennessee citizenship (valid Tennessee driver's license, Shelby County voter's registration card, or Memphis Library photo id card) in order to prevent processing delays.

You may also use the following 311 iTracker link <http://mapgis.memphistn.gov/applications/iTracker/#/search> to search any address for a history of open/closed Code Enforcement incidents in the city of Memphis. To utilize this system, select *Search Associated to Single Address*, type in the desired address, select the address, select *Show*

- The number of license plates scanned with Flock Safety automated license plate readers over the last 30 days
- The names of the hot lists/watch lists used with Flock Safety automated license plate readers
- The names of all the agencies with which data is shared with through the Flock Safety automated license plate reader system
- The names of all the agencies from which data is received through the Flock Safety automated license plate reader system
- All agreements with local homeowner associations or private business or individuals for access to Flock Safety systems
- All contracts, MOUs, or other agreements with Flock Safety
- All procurement documents related to Flock Safety

In advance of filing this public records request, we consulted with Flock Safety. The company explained that should your administrator have trouble locating these records, you should reach out to them for support.
