Dear Mr. Hoover:

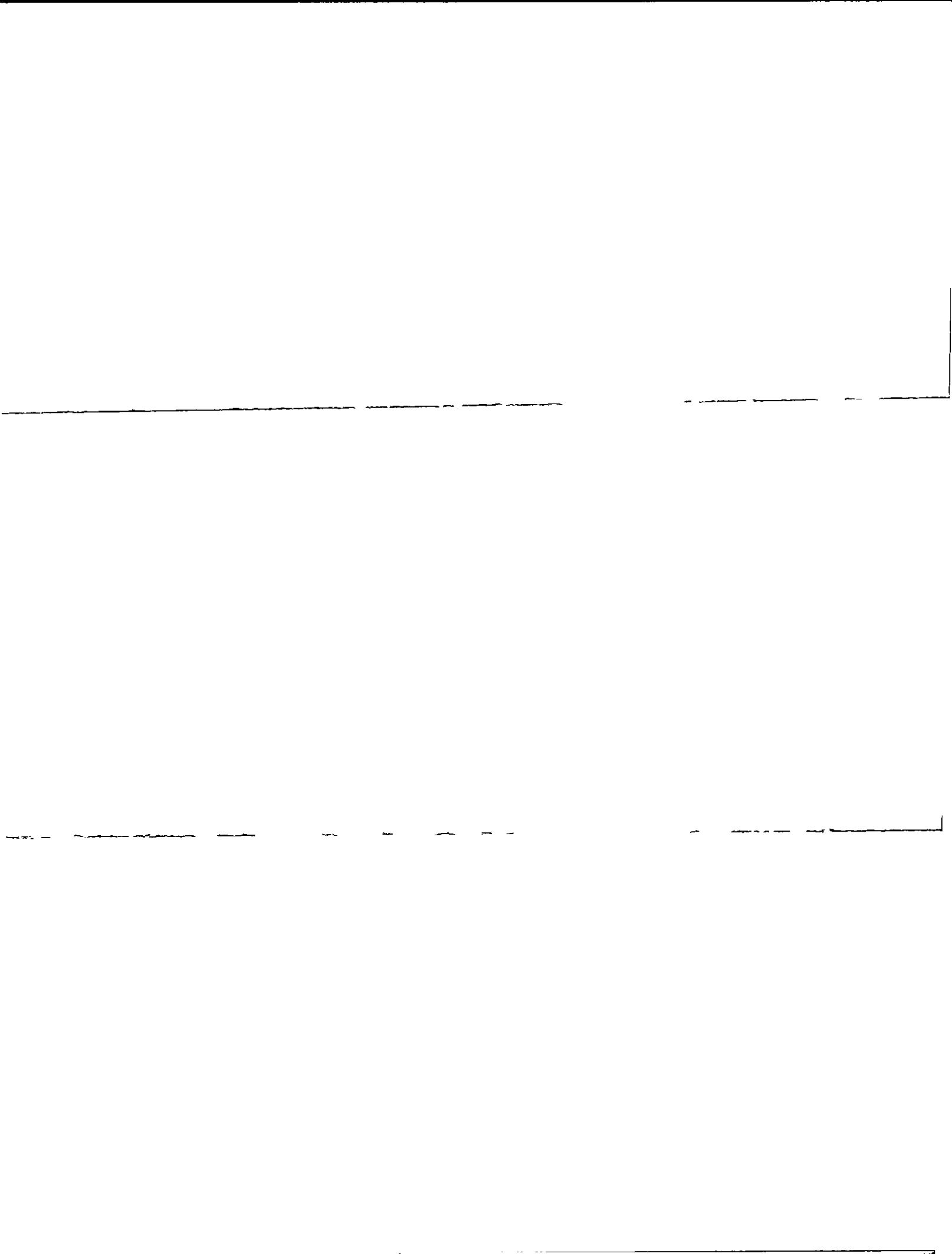

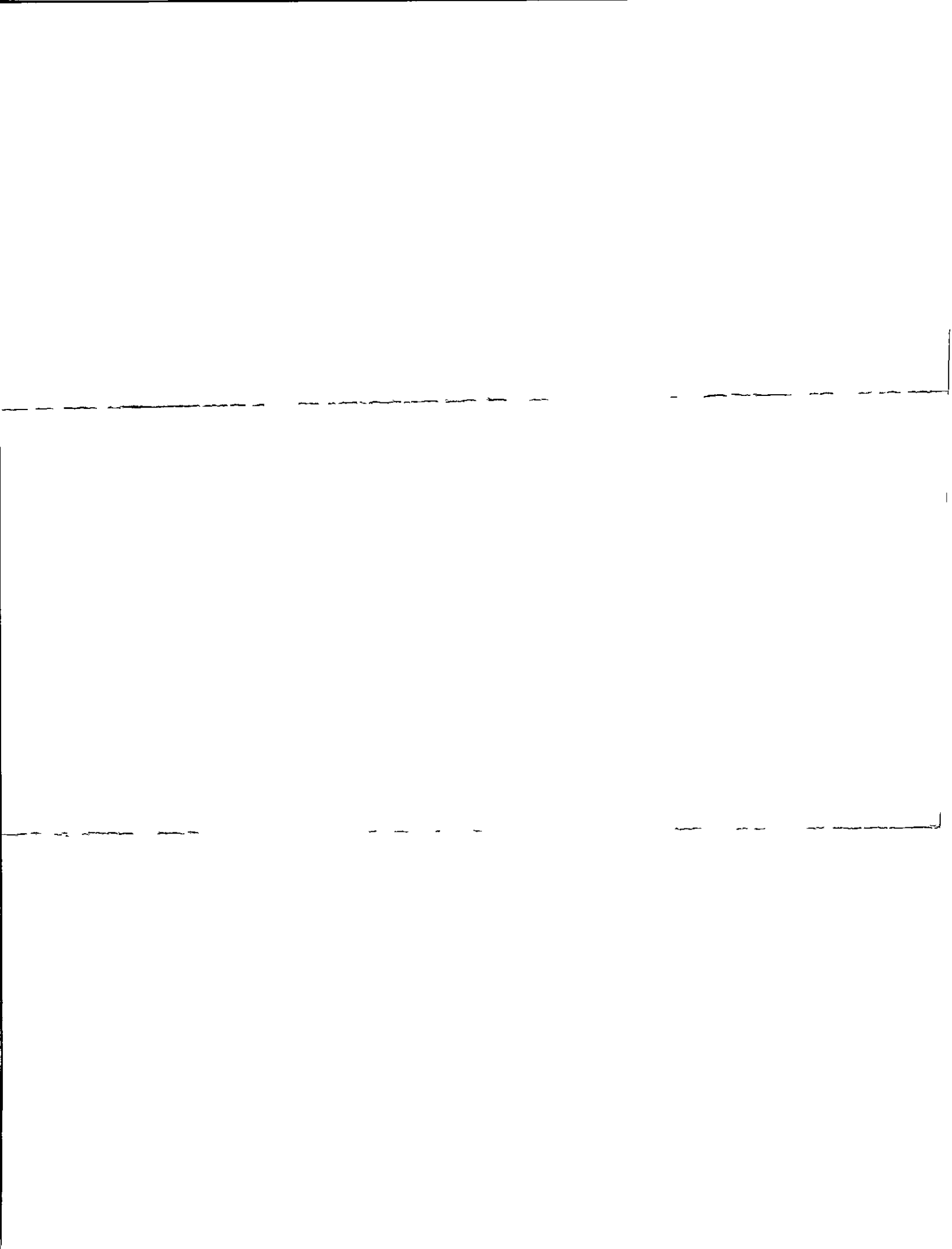
