When we spoke you had said cameras 23, 22 & 10 all needed batteries

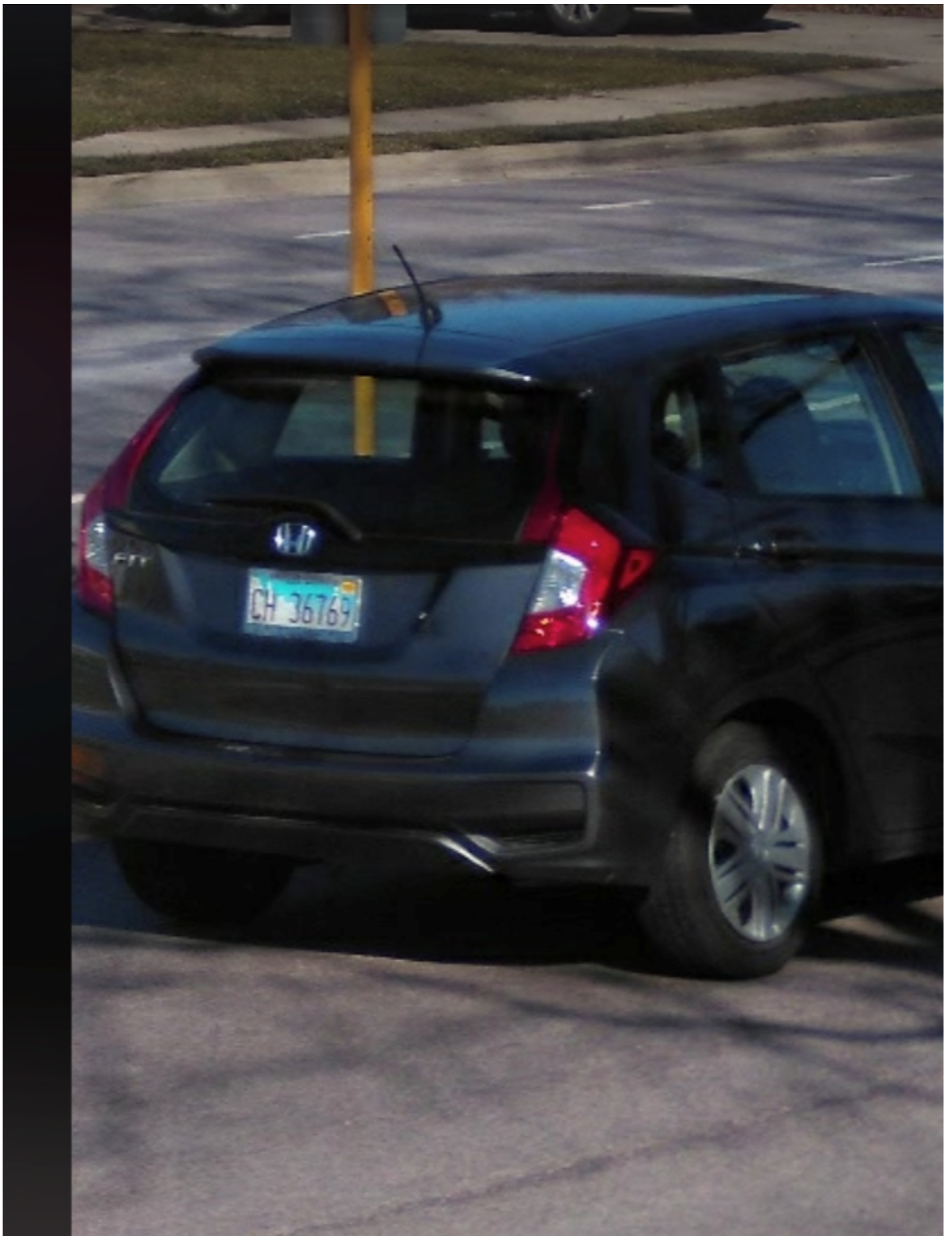
Camera 23 did get that battery pack addition on 2/28. Can you please have your guy confirm that its working well.

Camera 22 is registering as having no activity in a week. We are not seeing it connected to power period. That camera will be scheduled for a penguin pack (the internal name of the battery) after it leaves hibernation mode.

Camera 10 - We are also seeing this as not attached to power & have it slated to be swapped from A/C power to Solar on 3/8. If this not what you want and to have it stay A/C we are not seeing it ever connect to the power.

Camera 9. I'm not sure what the issue was here. The camera looks like it is up and working. Here are a couple captures randomly pulled from today. Maybe have you guy try driving by again and see if the issue is still there.

Please let me know if we need to set up a call.





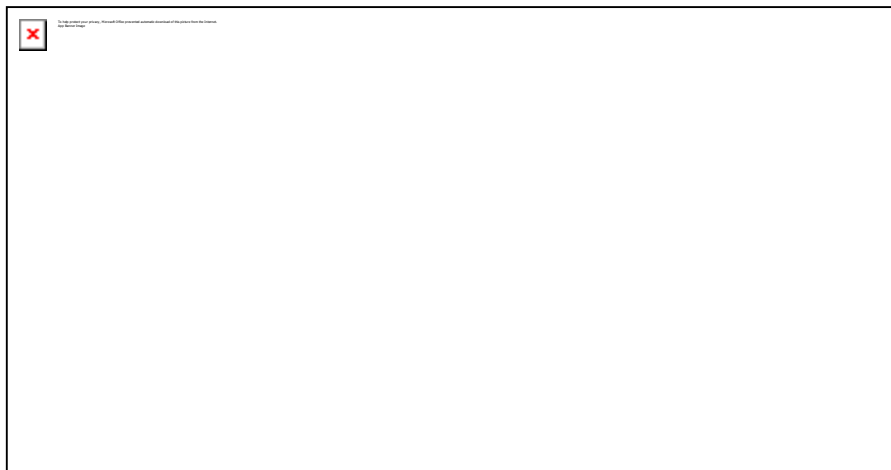

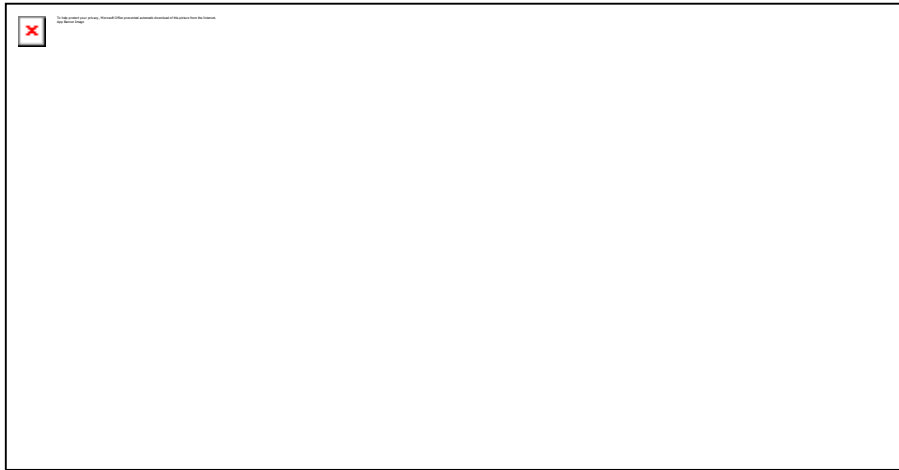

Thank you for the information!

I have let our Operations team know that Cameras 10, 22 & 23 were connected to power.

Sometimes if they sit for more than 72 hours without being hooked up to power after installation, they will go into a "hibernation mode" and we have to go out and swap the cameras themselves so that they kick on.

I am pending them to confirm if this is what's needed here and if so what dates we can get out there to perform that maintenance!

It looks like that is only the foundation spec sheet (in your attached email) for the IDOT permit for Camera 20.

While we do need that, we also need the pole spec sheet as well.
