Dear Recipient:

Thank you for contacting the National Personnel Records Center. The Privacy Act of 1974 provides for the release of information with the written consent (signature) of the individual to whom the records pertain. The Privacy Act does not apply to the records of deceased individuals; however, Department of Defense instructions indicate that in such cases we must have the written consent of the next of kin and proof of death. The next of kin is defined as: **unremarried widow or widower, son, daughter, father, mother, brother or sister**. The following are acceptable forms of proof of death:

- Death certificate
- Newspaper article (obituary) or death notice
- Coroner's report of death
- Funeral director's signed statement of death
- Verdict of coroner's jury
- If death occurred outside the United States, any document similar to one of the preceding five, or a report of death signed by a United States consul or other agent of the State Department.

The Department of Defense has determined that, under the provisions of the Freedom of Information Act (FOIA), certain items of information may be released without an unwarranted invasion of the individual's privacy. The enclosure provides all of the information about the veteran's military service that is releasable under FOIA.

The Privacy Act of 1974 does not permit the release of personal information without the authorization of the individual concerned; therefore, if present in the record, personal data pertaining to other individuals have been blacked out in the enclosed documents.

The photograph you requested is not on file at the National Personnel Records Center (NPRC). Individual photographs were not required of all persons who served in the Armed Forces and group photos are rarely found in the Official Military Personnel File.

Occasionally organizational group photos or photos of other military subjects like aircraft, ships, or vessels may be available from one of the addresses provided in the attached table. However, please be aware that boot-camp, basic training and induction type photos were often taken by private photographers, and were rarely retained as a permanent record by the various branches of service.



In addition, provide the veteran's personal identifying information.
