FLOCK GROUP INC. AMENDMENT ORDER FORM

This Amendment Order Form together with the Terms (as defined herein) describe the relationship between Flock Group Inc. (“**Flock**”) and the Agency identified below (“**Agency**”) (each of Flock and Agency, a “**Party**”). This Amendment Order Form (“**Order Form**”) hereby incorporates and includes the previously executed agreement, dated January 6, 2022 ,relating to the provision of services by Flock to the Agency (“**GOVERNMENT AGENCY CUSTOMER AGREEMENT/ FLOCK TERMS AND CONDITIONS**”) attached (the “**Terms**”), any schedules attached thereto, and incorporated herein by reference, which describe and set forth the general legal terms governing the relationship (collectively, the "**Agreement**"). The Terms contain, among other things, warranty disclaimers, liability limitations and use limitations. In full consideration of the continued promises and warranties contained therein, this Amendment Order Form shall supersede, amend and replace any prior agreements between the Parties relating to the subject hereof. The Parties understand and agree that any prior orders or agreements between the Parties have been replaced and any outstanding services provided by Flock are now subject to this Agreement.

The Agreement will become effective when this Order Form is executed by both Parties (the "Effective Date"). The Agreement will become effective when this Order Form is executed by both Parties (the “**Effective Date**”).

The GOVERNMENT AGENCY CUSTOMER AGREEMENT is amended as follows:

Notwithstanding anything to the contrary in the Agreement, the Pilot Period shall extend to a total of **sixty (60) days**. Agency shall not incur any fees during the Pilot Period and may choose to cancel at any time during the Pilot Period at no additional cost. Flock Safety shall provide Advanced Search for no additional cost during the length of the 60 day Pilot Period. After Pilot Period, Agency shall be invoiced full cost of services as described in the chart below for a Year 1 total of \$86,000 to be paid within 30 days receipt of invoice.
