After weeks of gathering feedback and reviewing potential sites, our Department has chosen the final locations for installing most of its remaining Smart Streetlights.

As we discussed at the City Council meeting on Dec. 17th, the Department ran into several issues while installing the 500 cameras that were first approved in August 2023. These challenges included locations that didn't have power, poles that were misidentified and belonged to the state, locations with views that were blocked by trees or signs, and poles that had been removed completely to make way for new construction.

Those struggles left the department with about 60 unplaced cameras. Following the City Council's decision to grant the Department the flexibility it needed to install the rest of its inventory, we reached out to various stakeholders to gather feedback about where our remaining cameras should go. We received more than 100 suggestions.

The Department considered crime data, investigator feedback, pedestrian and traffic safety concerns, and input from residents and city leaders when settling on the below locations:
