Mr. McIntosh,

The City is in receipt of your public records request for:

- “1) The name of any vendors or manufacturers that your department purchases license plate reader technology from. This may include but is not limited to cameras, software, or other technology to support automated reading of license plates in the areas your department serves.**
- 2) The name of any vendors that your department partners with to install or perform maintenance on license plate reading technology (e.g., cameras and other software). These partners may also be known as integrators.**
- 3) Where available, the contracts or purchase agreements with the vendors or parties included in the above two bullets.**
- 4) Addresses, or geolocation information for installed and operational license plate reader technology controlled and/or operated by your department.**
- 5) Model information for each reader identified in the fourth bullet.**

The City is unsure if it is the custodian of some or all of the requested records. Some of the material within those records may be exempt from disclosure pursuant to ORS 192.345(23).

The City estimates it will require approximately 2 hours of staff (Research fee \$53.27 per hour X 2 hrs) time to identify records responsive to this request.

Once the City receives payment of **\$106.54** staff will begin processing your request. As we begin work, our estimates of the time it will take to process your request and/or the cost of processing your request may change. If we believe it will take longer or cost substantially more to process your request than we originally anticipated, we will provide you with an updated time and/or cost estimate. If the estimated cost exceeds the actual cost of responding to your request, the City will refund the difference. If the actual cost of processing your request exceeds the amount you have paid the City, you will be required to pay the difference before the City will provide the records you have requested.

Regarding your request for a fee waiver or fee reduction, your request is denied. In addition to reasons that this City will grant a fee waiver that are set forth in Admin Order No. 21-05-06-F, when deciding whether or not to grant a requested fee waiver or reduction, the City considers whether doing so is in the public interest because making the requested record available *primarily benefits* the general public. Based on this criterion and the broad scope of your request, the City has determined that a fee waiver will not be granted.

Once payment is received, we will locate and copy the records noted in your request. If payment is not received within 60 days, your request will be closed.

Pursuant to ORS 192.329(3)(a) the City will not begin to compile responsive documents until the fee is paid.

If an exemption has been asserted, you may seek review of that decision pursuant to ORS 192.415.
