Mr. May,

The City is in receipt of your public records request for:

1. Organization Audit in Flock.

The report should include data logged from the period of March 1, 2025, to the date this request is processed. Per Flock's documentation, the Organization Audit is available within the Insights tab and is defined as searches done within the agency.

2. Network Audit in Flock.

The report should include data logged from the period of March 1, 2025, to the date this request is processed. Per Flock's documentation, the Network Audit is available within the Insights tab and is defined as searches of the organization's Flock network by any agency in the Flock System.

The City is the custodian of the requested records, however some of the data contained in these records may be exempt from disclosure pursuant to ORS 192.345(3) and ORS 181A.825(1)(b).

Please note the Oregon State Law (ORS 192.324(4)(a)) authorizes the City to establish fees "reasonably calculated to reimburse it for the actual cost in making records available".

What follows is our estimate to respond to your request.

1. Organization Audit in Flock.

The report should include data logged from the period of March 1, 2025, to the date this request is processed. Per Flock's documentation, the Organization Audit is available within the Insights tab and is defined as searches done within the agency.

Response: The City is the custodian of organizational audits within the Flock system, however some of the information within these audits is exempt from disclosure pursuant to ORS 192.345(3), ORS 181A.825(1)(b) or others. The City will need to research the case status for each entry to determine whether it is exempt pursuant to ORS 192.345(3) or another statute. During a preliminary search, the City identified 2,637 lines of data to be reviewed for the network audit for the month of October. The City does not currently know the aggregate number of responsive records for the requested 7 month period. The City estimates approximately 10,548 lines of data for the requested 7 month period based on October's totals while also considering deployment dates. Using this as a guideline and estimating 5 minutes of research per entry, the cost to respond to this element of your request is \$48,731.76. (Research Fee \$55.44 per hour X 879 hrs)

The City can significantly reduce this estimate by redacting the fields for user name, plate number, and case number. If you would like to amend your request to omit these fields entirely, the estimate to respond to this element of your request would be **\$55.44** (Research Fee \$55.44 per hour X 1 hr)

2. Network Audit in Flock.

The report should include data logged from the period of March 1, 2025, to the date this request is processed. Per Flock's documentation, the Network Audit is available within the Insights tab and is defined as searches of the organization's Flock network by any agency in the Flock System.

Response: The City is the custodian of network audits within the Flock system, however some of the information within these audits is exempt from disclosure pursuant to ORS 192.345(3), ORS 181A.825(1)(b) or others. The City will need to research the case status for each entry to determine whether it is exempt pursuant to ORS 192.345(3) or another statute. Since these include cases from outside agencies, research will take longer than the time estimated for the organizational audit. During a preliminary search, the City identified 6,569 lines of data to be reviewed for the network audit for the month of October. The City does not currently know the aggregate number of responsive records for the requested 7 month period. Using October's totals, the City estimates approximately 26,276 lines of data to review for the requested 7 month period while also considering deployment dates. Using this as a guideline and estimating 10 minutes of research per entry, the cost to respond to this element of your request is \$242,771.76. (Research Fee \$55.44 per hour X 4379 hrs)

The City can significantly reduce this estimate by redacting the fields for user name, plate number, and case number. If you would like to amend your request to omit these fields entirely, the estimate to respond to this element of your request would be **\$55.44** (Research Fee \$55.44 per hour X 1 hr)

Please let us know how you would like us to proceed or if you would like to modify the scope or time period of your request. Once the City receives payment for the work to be performed staff will begin processing your request. If we believe it will take longer or cost substantially more to process your request than we originally anticipated, we will provide you with an updated time and/or cost estimate. If the estimated cost exceeds the actual cost of responding to your request, the City will refund the difference. If the actual cost of processing your request exceeds the amount you have paid the City, you will be required to pay the difference before the City will provide the records you have requested.

If you would like to receive these records, you may pay the fee with credit card by going to <https://www.eugene-or.gov/916/Public-Records-Office>, (you will need to click on the Public Record Request button in order to fill in the PRR number). Or mail in a check/money order to 300 Country Club Rd, Eugene OR 97401. When making payment, please reference PRR EPD-2024-3891. Once payment is received, we will locate and copy the records noted in your request. If payment is not received within 60 days, your request will be closed.

Pursuant to ORS 192.329(3)(a) the City will not begin to compile responsive documents until the fee is paid. Please let me know how you would like to proceed within 60 days, or your request will be closed.
