5	Toxicology report	RCW 46.52.065	Prohibits release of blood sample analyses done by Washington State toxicology
6	Attorney work product	RCW 42.56.280	The record constitutes/includes preliminary drafts, notes, recommendations and/or intra-agency memoranda in which opinions are expressed or policies formulated or recommended and which have not been publicly cited by our agency in connection with any agency action.
7	Juvenile victim or witness	RCW 42.56.240 (5)	Prohibits release of information pertaining to juveniles as a witness or victim of a sex crime.
8	Juvenile victim or witness	RCW 7.69A.010; RCW 7.69A.030 (4)	Prohibits release of identifying information, names, address or photos, pertaining to juveniles listed as a witness or victim of a crime.
9	Juvenile interviews	RCW 42.56.240 (18)	Prohibits release of any and all audio or video recordings of child forensic interviews..
10	Juvenile suspects	RCW 13.50.050 (3)	Prohibits release of police reports pertaining to juveniles involved in criminal activity.
11	Non-Disclosure of Subject	RCW 42.56.240 (2)	Prohibits release of disclosure of information revealing the identity of persons who are witnesses to or victims of crime or who file complaints with investigative, law enforcement, or penology agencies, other than the public disclosure commission, if disclosure would endanger any person's life, physical life, physical safety, or property. If at the time a complaint is filed the complainant, victim or witness indicates a desire for disclosure or nondisclosure, such desire shall govern .
12	APS report	RCW 74.34.095	Prohibits release of Adult Protective Services report.
13	CPS report	RCW 74.13.500	Prohibits release of Child Protective Service reports.
14	Military report	RCW 42.56.240(1)	These records are exempt from public inspection and copying because they are specific investigative records compiled by a law enforcement agency, the nondisclosure of which is essential to effective law enforcement.
15	Deceased photos	RCW 42.56.240 (1); RCW 42.56.050	Prohibits release of photos of deceased persons.

16	Criminal history	RCW 10.97.030(1)	Prohibits release of criminal history.
17	Fingerprints	RCW 70.48.100(2)	Prohibits release of information obtained by the jail.
18	Non-Disclosure effective law enforcement	RCW 42.56.240(1)	Non disclosure essential to effective law enforcement.
19	Driver's Abstract	RCW 46.52.130(3)	Prohibits release of a driver's abstract to the public.
20	Account information	RCW 42.56.230(5)	Prohibits release of credit or debit card numbers, electronic check numbers, card expiration dates, or bank or other financial account information as defined in RCW 9.35.005 (Account numbers, balances and transactional information concerning an account)
21	Medical information/ effective law enforcement/ investigative records	RCW 70.02.005; RCW 42.56.240(1)	Prohibits release of health care information even when the person or agency who is obtaining, using or disclosing the information is not a "health care provider." Investigative records the nondisclosure of which is essential to effective law enforcement or for the protection of any person's right to privacy.
22	Right of privacy	RCW 42.56.050; RCW 42.56.240(1)	Prohibits release of information due to right of privacy, highly offensive to involved persons if released to the public, and not of legitimate concern to the public.
23	Mental Health records or Right of Privacy	RCW 70.02.230; RCW 42.56.240(1)	Prohibits release of records related to receipt of services for mental health are confidential or for the protection of any person's right to privacy.
24	Autopsy	RCW 68.50.105	Prohibits release of the autopsy report or information from the report.
25	Toxicology report	RCW 46.52.065	Prohibits release of blood sample analyses done by Washington State toxicology
26	Active Investigation	RCW 42.56.240(1); <i>Newman v. King County</i> , 133 Wn.2d 565 (1997)	Records in an active investigation compiled by law enforcement, the non-disclosure of which is essential to law enforcement
27	Public employee or volunteer' home address or phone number, email, payroll deductions, emergency contact info	RCW 42.56.250 (1)(d)	Prohibits release of City employee or volunteer for the City, home address, residential or personal cell phone numbers, or personal email address.
28	Public employee birthdate	42.56.250 (1)(h)	Prohibits release of month/year of birthday for public employees.
29	School Records	20 U.S.C. § 1232g; 34 CFR Part 99	Family Educational Rights and Privacy Act (FERPA) prohibits release of student education records.
30	Personal Information - Schools	RCW 42.56.230(1)	Prohibits release of personal information in any files maintained for students in public schools..
31	Police tactics	RCW 42.56.240 (1)	Prohibits release of agency tactics that could compromise effective law enforcement.

32	Intelligence information	RCW 42.56.240(1)	Specific intelligence information and specific investigative records compiled by investigative, law enforcement, the nondisclosure of which is essential to effective law enforcement or for the protection of any person's right to privacy
33	Confidential source	RCW 42.56.240(1); RCW 42.56.240(2); RCW 5.60.060(5)	Prohibits release of information in Investigative records the nondisclosure of which is essential to effective law enforcement or for the protection of any person's right to privacy.
34	Jail Records	RCW 42.56.070(1); RCW 70.48.100	Prohibits release of Jail records – all records including booking photos, medical information, and custodial care information.
35	Currency images	18 U.S.C. § 474	Prohibits release of plates, stones, or analog, digital, or electronic images of currency.
36	Employment testing	RCW 46.56.250 (1)(a)	Prohibits release of test questions, scoring keys, and other examination data used to administer a license, employment or academic examination
37	Performance Evaluations including Performance Improvement Plans	RCW 42.56.230 (3); RCW 42.56.050.	Personal information maintained for employee to the extent disclosure violates right to privacy. Dawson v. Daly
38	Suspect information - Sexual Assault	RCW 42.56.240 (1)	when persons have been accused of sexual crimes but have not been convicted, the person has a privacy interest in their "identifying information"
39	Identify of Victim Sexual Assault	RCW 42.56.240 (1); RCW 42.56.050	Specific investigative records compiled by investigative and law enforcement agencies, the nondisclosure of which is essential for the protection of any person's right to privacy. Disclosure of a sexual crime victim's identity: would be highly offensive to a reasonable person, and not of legitimate concern to the public.
40	CPL Application/Information	RCW 42.56.240 (4)	Prohibits release of CPL license applications under RCW 9.41.070: copies of license applications or information on the applications
41	Biometric Identifiers	RCW 40.26.020 (5); RCW 40.26.020 (7)(b)	Prohibits release of biometric identifiers. "Biometric identifier" means any information, regardless of how it is captured, converted, stored, or shared, based on an individual's retina or iris scan, fingerprint, voiceprint, DNA, or scan of hand or face geometry
42	CPS information	RCW 26.44.030 (9); RCW 26.44.030 (7)	Persons or agencies exchanging information under subsection (7) of this section shall not further disseminate or release the information except as authorized by state or federal statute.

43	Security Passwords/Codes	RCW 42.56.420(4)	Information regarding the public and private infrastructure and security of computer and telecommunications networks, consisting of security passwords, security access codes and programs, access codes for secure software applications, security and service recovery plans, security risk assessments, and security test results to the extent that they identify specific system vulnerabilities, and other such information the release of which may increase risk to the confidentiality, integrity, or availability of security, information technology infrastructure, or assets
44	Dependents of city employee or volunteer' name, address, date of birth, phone number, email	RCW 42.56.250 (1)(d)	Prohibits release of dependents of City employee or volunteer for the City, name, date of birth, home address, residential or personal cell phone numbers, or personal email address.
45	Applications for public employment	RCW 42.56.250 (1)(b)	Prohibits release of all applications for public employment other than for vacancies in elective office, including the names of applicants, resumes, and other related materials submitted with respect to an applicant;
46	Employee W4, retirement documents, direct deposit	RCW 42.56.230 (3)	Prohibits release of Personal information in files maintained for employees, appointees, or elected officials of any public agency to the extent that disclosure would violate their right to privacy
47	Attorney/Client privilege	RCW 5.60.060(2)	redactions are based on attorney-client privilege either as legal advice, request for legal advice or factual information provided to an attorney to allow the attorney to provide legal advice.
48	Employee personal information	RCW 42.56.230(3)	Personal information in files maintained for employees, appointees, or elected officials of any public agency to the extent that disclosure would violate their right to privacy;
49	Juvenile records which do not relate to the commision of a criminal offense	RCW 13.50.050 (3)	Provides that juvenile non-offender records shall be confidential and shall be released only pursuant to RCW 13.50.100 and RCW 13.50.010.
50	Suicide note	RCW 42.56.050; RCW 42.56.240(1); Comaroto v. Pierce County Medical Examiner's Office, 111 Wn.App 69, 43 P.3d 539 (2002).	Prohibits release of information due to right of privacy, highly offensive to involved persons if released to the public, and not of legitimate concern to the public.
51	L&I claims	RCW 7.68.140	Information contained in the claim files and records of victims, under the provisions of this chapter, shall be deemed confidential and shall not be open to public inspection
52	SMART911	RCW 42.56.230 (9)	Prohibits release of voluntarily submitted information contained in a database that is part of or associated with 911 emergency communications systems, or information contained or used in emergency notification systems as provided under RCW 38.52.575 and 38.52.577 ;

53	Gang Database	RCW 43.43.762	The database and all contents in the database are confidential and exempt from public disclosure under chapter 42.56 RCW.
54	Tax Records	26 U.S.C. § 6103; RCW 82.32.330; RCW 42.56.050; RCW 42.56.240(1)	Prohibits release of tax records and tax information due to right of privacy, highly offensive to involved persons if released to the public, and not of legitimate concern to the public.
55	Religious Affiliation	RCW 42.56.235	All records that relate to or contain personally identifying information about an individual's religious beliefs, practices, or affiliation are exempt from disclosure
