We just handled a fatal pedestrian crash at Island Lake PD and I discovered that there are no speed limit signs posted EB IL Route 176 between Westridge Dr. and Orchard Dr. where it changes from 35mph to 45. E/B 176 goes from 35mph to 50mph and W/B goes from 50mph to 45mph to 35mph so the speed limit is different for each direction. The fatal crash occurred in this area and we are thinking the speed limit should be 45 but its not posted. Thank you, Chief of Police Jennifer Paulus
