Dear Ms. Jones,

This Department is in receipt of the November 4, 2025 request from you requesting information regarding Flock Safety Network Audits that occurred on 1/23/2025, 1/28/2025 and 1/31/2025 held by the Moraga Police Department.

The Town wishes to cooperate to the fullest extent possible with the Public Records Act (Government Code section 7920 et. seq.). Under established California law, the Town is obliged to comply with a request for a public record so long as the requestor makes a specific and focused request for information, that information is maintained by the Town in its ordinary course of business, the information is disclosable, and the record can be located with reasonable effort. It does not compel the Town to create new records, lists, privilege logs or reports in response to a request. Furthermore, there may be exemptions which preclude the production of documents, including certain law enforcement records.

The Town is required to determine whether the request, in whole or in part, seeks copies of disclosable public records. Ordinarily, this determination must take place within ten (10) days of the Town's receipt of the request. However, Government Code Section 7922.535(b) authorizes the Town to extend the time for making this determination by up to fourteen (14) days if the Town needs to search for, collect and appropriately examine a voluminous amount of separate and distinct records that are demanded in a single request.

Consistent with the above, the Town has reviewed your request and has made the following determinations:

The Town does not have any records within its custody, control or possession responsive to this request. As a courtesy, the Town responds that it was not a Flock subscriber during the dates noted in your request.
