Please let me know if you have any questions.

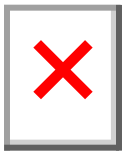

The status in my planning portal is the below image. It says, “Awaiting Customer Approval”, but no one on our team has access to approve it further than it already has been.






