

AMENDATORY AGREEMENT

THIS AMENDATORY AGREEMENT is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the “City”), **FLOCK GROUP INC**, a Delaware corporation whose address is 1170 Howell Mill Rd NW Ste 210, Atlanta, GA 30318-8637 (the “Contractor”), individually a “Party” and jointly “the Parties.”

WHEREAS, the Parties entered into an Agreement dated February 12, 2024, for solar powered license plate recognition cameras (the “Agreement”); and

WHEREAS, the Agreement expired by its terms on February 28, 2025, and rather than enter into a new agreement, the Parties wish to revive and reinstate all terms and conditions of the Agreement as they existed prior to the expiration of the term and to amend the Agreement as set forth below.

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties incorporate the recitals set forth above and amend the Agreement as follows:

1. As of March 1, 2025, all references to “Exhibit B” in the Agreement shall now refer to “Exhibits A and B-1,” as applicable to the context. Exhibit B-1, attached hereto and incorporated herein by reference, shall govern with respect to its specific subject matter from and after March 1, 2025. In the event of any conflict between Exhibit A and Exhibit B-1, Exhibit B-1 shall control.

2. Section 4 of the Agreement, titled “**TERM**,” is amended to read as follows:

“4. **TERM**: This Agreement will commence on March 1, 2023, and will expire, unless sooner terminated, on October 30, 2025 (the “Term”). Following the Term, this Agreement may be renewed, by a written amendment executed by the Parties, for successive renewal terms of the greater of one year or the length set forth in an Order Form (each, a “Renewal Term”).”

3. Subsection 5.4.1 of the Agreement, titled “**Maximum Contract Amount**,” is amended to read as follows:

“5.4.1. Notwithstanding any other provision of the Agreement, the City’s maximum payment obligation will not exceed Four Hundred Ninety-Eight Thousand Five Hundred Nine Dollars and Seven Cents (\$498,509.07) (the “Maximum Contract Amount”). The City is not obligated to execute an agreement or any amendments for any further services, including any services performed by the Contractor beyond that specifically described in the Exhibits. Any services performed beyond those in the Exhibits or performed outside the Term are performed at the Contractor’s risk and without authorization under the Agreement.”

4. Except as amended here, the Agreement is affirmed and ratified in each and every particular.

5. This Amendatory Agreement is not effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.


