

## AMENDATORY AGREEMENT

This **AMENDATORY AGREEMENT** is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the “City”) and **WEST PUBLISHING CORPORATION**, a Minnesota Foreign Corporation, with an address of 2900 Ames Crossing Road, Suite 100 Eagan, MN, 55121 (the “Contractor”), jointly (“the Parties”).

### RECITALS:

**A.** The Parties entered into Agreement dated April 16, 2020, to perform, and complete all of the services and produce all the deliverables set forth on **Exhibit A and B**, the Scope of Work and Budget, to the City’s satisfaction.

**B.** The Parties wish to amend the Agreement to increase funding, extend the term, amend the scope of work and budget exhibits, and amend section 20 - No Discrimination in Employment.

**NOW THEREFORE**, in consideration of the premises and the Parties’ mutual covenants and obligations, the Parties agree as follows:

**1.** Section 3 of the Agreement entitled **TERM**: is hereby deleted in its entirety and replaced with:

“**3. TERM**: The Agreement will commence on **January 1, 2020**, and will expire on **June 30, 2026** (the “Term”). Access to and billing for the CLEAR Service will commence upon successful accreditation of the agency requesting services.

**2.** Section 4 of the Agreement entitled “**COMPENSATION AND PAYMENT**”, subsection **d.1.** entitled “**Maximum Contract Amount**:” is hereby deleted in its entirety and replaced with:

“**4. COMPENSATION AND PAYMENT**:

**d. Maximum Contract Amount**:

(1) Notwithstanding any other provision of the Agreement, the City’s maximum payment obligation will not exceed **SEVEN HUNDRED SEVENTY THOUSAND DOLLARS (\$770,000.00)** (the “Maximum Contract Amount”). The City is not obligated to execute an Agreement or any amendments for any further services, including any services performed by Vendor beyond that

specifically described in **Exhibits A and B**. Any services performed beyond those in **Exhibits A and B** are performed at Vendor's risk and without authorization under the Agreement.

3. Section 20 of the Agreement entitled "**NO DISCRIMINATION IN EMPLOYMENT**:" is hereby amended to read:

**"20. NO DISCRIMINATION IN EMPLOYMENT:** In connection with the performance of work under the Agreement, the Contractor may not refuse to hire, discharge, promote, demote, or discriminate in matters of compensation against any person otherwise qualified, solely because of race, color, religion, national origin, ethnicity, citizenship, immigration status, gender, age, sexual orientation, gender identity, gender expression, marital status, source of income, military status, protective hairstyle, or disability."

4. All references to "...**Exhibit A**" in the Agreement shall be amended to read: "...**Exhibit A and A-1**..." as applicable. All references to "...**Exhibit B**" in the Agreement shall be amended to read: "...**Exhibit B and B-1**..." as applicable. The scope of work and budget marked as **Exhibit A-1 and Exhibit B-1** attached to this Amendatory Agreement is hereby incorporated by reference.

5. As herein amended, the Agreement is affirmed and ratified in each and every particular.

6. This Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
