Final Contracts and Agreements

- The final executed contract(s), amendments, renewals, and statements of work between the City of Canton and Flock Safety.

City Council Records

- City Council meeting minutes and publicly distributed agenda packets where Flock Safety or ALPR technology was discussed or approved.

Policies and Governance

- Final policies, procedures, or guidelines governing the use of Flock Safety or ALPR technology, including any privacy, data retention, or access-control policies.

Data Access and Sharing

- Documents identifying which City departments are authorized to access Flock Safety data.
- Any final agreements or written policies allowing data sharing with third parties, including other governmental entities or vendors.

Audits and Misuse Reviews

- Any completed audits, compliance reviews, or substantiated complaints related to misuse or improper access of Flock Safety data.

Third-Party Vendors

- A list or documentation identifying third-party vendors or platforms that have authorized access to Flock Safety data through integrations or data-sharing agreements.

The requested documents will be made available to the general public, and this request is not being made for commercial purposes.
