Reason	Page (# of occurrences)	Description
M.G.L. ch. 4, §7(26)(c)	2 (2)	Information that is personnel information or medical information, except salary or records related to police officer misconduct. Information or records commonly withheld under this exemption are: • Officer personnel files; • Records related to the discussion of officer discipline; • Traffic accident casualties; • Discussion of any medical conditions, past health history or procedures, and medical records; • Video footage inside a hospital or other healthcare facility. Certain information that would be an “Unwarranted Invasion of Privacy” if released, such as: • Bystander faces, auto license plates, or other private information; • Nudity; • Minors; • Personal information for the participants in a video; • Witness names, dates of birth, cell phone numbers, and home addresses; • Social Security Numbers; • References to criminal history, arrests, and/or filing charges against another; • Audio redactions may be required to protect the identity of complainants, and witnesses.
