SCOPE OF WORK FOR CSPD BODY WORN CAMERA (BWC) AND DIGITAL EVIDENCE MANAGEMENT SYSTEM (DEMS) REPLACEMENT

This Scope of Work (SOW) outlines various requirements of the City of Colorado Springs (City) and Axon Enterprise, Inc. (Axon) for the duration of this purchasing agreement. It serves as an addendum to the original purchasing agreement entered into on 09/30/2024, to which this SOW is fully attached and incorporated.

GENERAL

CSPD wishes to update the 09/30/2024 purchasing agreement to add Axon services including Draft One (artificial intelligence report narratives), and four (4) additional Axon Air pilot licenses.

CSPD wishes to add the City's current Fusus contract into our Axon purchasing agreement, as Fusus is now owned by Axon.

All product and service additions are detailed in the attached Quote Q-608238-45623.673MS.

CSPD wishes to remove the requirements for Axon to conduct migration of legacy CSPD body worn camera data, as CSPD will partner with a third-party vendor to conduct the migration.

GENERAL USE CASE

No additional general use case information is provided.

Use Case 11: LEGACY BWC AND DEMS DATA MIGRATION

The following requirements of Axon are updated from Section 11: Legacy BWC and DEMS Data Migration in the prior Statement of Work signed on 09/30/2024.

1. Any requirements that Axon conduct the migration of legacy Utility data into evidence.com are removed.
2. Axon shall assist the City, Utility, and the City's migration vendor to the reasonable extent necessary to move Utility data into evidence.com via API or other interface, and engage in good faith efforts to ensure the migration is accomplished by 03/01/2025.
3. Axon shall provide reasonable technical, personnel, and other resources to assist Utility, the City, and our migration vendor moving data into evidence.com at no additional cost to the City from Axon.
4. The City shall assume no additional costs from Axon for the migration of Utility data into evidence.com.
5. Axon will provide a credit on the above-referenced quote for all migration service costs in the 09/30/2024 purchasing agreement. In the event the City is unable to effectively migrate Utility data into evidence.com via the selected vendor, Axon will allow the City to reenter migration discussions with Axon at the price listed on the 09/30/2024 purchasing agreement.
6. All requirements related to migration of Foray DIMS evidence are still in effect, except that the timeline for the DIMS migration is now six months from the conclusion of the Utility data migration into evidence.com, provided the City confirms that Axon will be providing this service within 5 calendar days of signing this amendment.
7. The City may, at its discretion, choose to utilize a third-party vendor to conduct the DIMS migration. If this occurs, points #1-5 of this section will apply to the DIMS data migration as well.

Use Case 13: DRAFT ONE REPORT NARRATIVE GENERATION SYSTEM

Axon shall provide the City with its latest, fully functional automated report narrative generation system (Draft One). The system shall meet all Criminal Justice Information Services (CJIS) Security Policy and Federal, State, and Local governance requirements as they apply for data protection and storage. This is inclusive of all City data (video, audio, metadata, and other information) generated or stored by Axon's provided devices and services.

The provided solution from Axon shall meet or exceed the following minimum requirements:

1. A vendor-built automated report narrative service that creates draft-report narratives from transcribed Axon body camera, Fleet Vehicle, and third-party audio and video uploaded into evidence.com.
2. Use of the service for all City users with a Pro user license or assigned Axon body worn camera, if given appropriate system permissions by the City and provided the City maintains services on the purchasing agreement required to run the service. Axon may impose usage restrictions if a single user generates more than two hundred (200) reports per month for two or more consecutive months.
3. The service should be accessible to users within ten minutes of a) the termination of a recording on any Axon body worn camera or Fleet service; or b) the completion of any automated transcription from any third-party audio or video-with-audio recording into evidence.com. City recognizes the audio and video must be playable in evidence.com for it to be transcribed.
4. The service shall require a user acknowledgement and have either a customizable or standard acknowledgement at CSPD's discretion.
5. The service shall allow for insertion of intentional errors into automated narratives, for the purpose of requiring user review of a narrative prior to user availability. This setting shall be at CSPD's discretion.
6. The service shall allow CSPD to set minimum change requirements for narratives prior to user availability. The service will not allow submission of the report without the changes being completed by the user, and the percentage of change needed is selectable by CSPD.
7. The service shall allow CSPD to select what types of incidents (e.g. – minor crime, major crime, etc.) are approved.
8. The service shall allow for customizable headers and footers in each narrative, as determined by CSPD.
9. The service shall allow for the narrative to be copied from and then used outside its native evidence.com environment (e.g. – a completed report narrative can be copied from the service and used/pasted in Microsoft Word).
10. The service shall produce draft report narratives, information, names, dates and times, and other information only directly related to the information identified in the transcription produced from the video or audio for draft narrative production. The service shall include and have seamless integration with evidence.com.
11. The first two years (24 months) of the service will be at no cost to the City.
12. The Axon SaaS service used to deliver this capability to the City shall be scalable to ensure availability to the City in accordance with Axon's Service Offerings Agreement included in the Purchasing Agreement.
